

# Memo to a foreign student on registration



# Rules of behavior in public places



**Foreign citizens, enrolled in the university, are required to register in the territorial division of the State Registration Service under the Ministry of Digital Development of the Kyrgyz Republic at the place of study.**

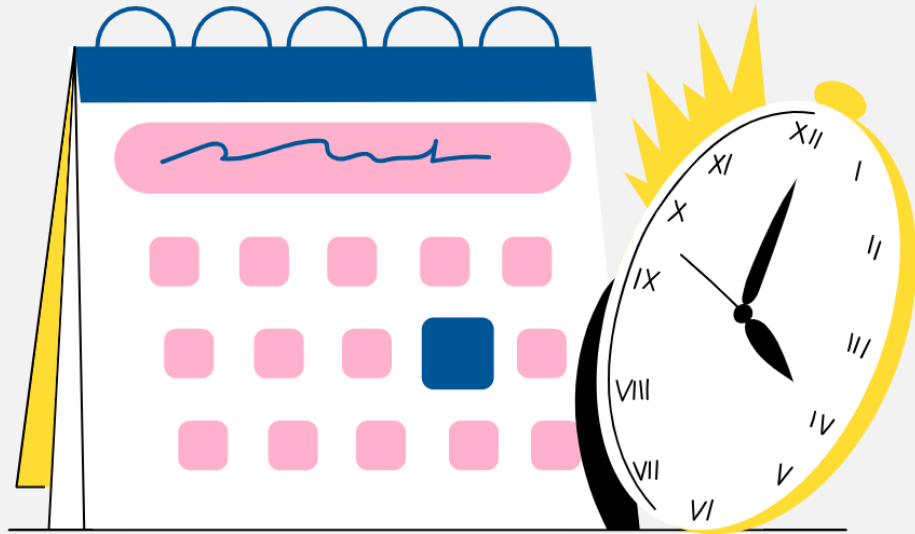


Registration of foreign citizens is carried out upon arrival in the territory of the Kyrgyz Republic and upon extension of a study visa. Foreign students, immediately after arrival in Kyrgyzstan, must contact the Department of International Relations of the RMU (hereinafter referred to as the IR RMU) to confirm their status, to receive the necessary instructions and to register.



Registration of foreign citizens and stateless persons enrolled in educational institutions of the Kyrgyz Republic is carried out for the duration of the study visa;

for foreign citizens of states with a visa-free regime - for one academic year, subject to a certificate from the place of study and an agreement between the foreign student and the RMU.



A foreign student must apply for a visa extension 30 days before its expiration by contacting the IR RMU. The study visa is extended up to 1 year depending on the term of the agreement with the university. After the extension of the study visa, the student is required to register within 24 hours.



**IMPORTANT:** RMU does not submit applications for visa extension for foreign students who have already graduated from the university, are on academic leave or have been expelled from the university. Violation of the procedure for stay by foreign citizens such as visa overdue, failure to comply with the established registration procedure entails liability in accordance with the legislation of the Kyrgyz Republic. Registration of visas is exclusively within the competence of the Ministry of Foreign Affairs of the Kyrgyz Republic and RMU cannot influence this process.



Foreign citizens who arrived in the Kyrgyz Republic to study cannot be employed in the territory of the Kyrgyz Republic. (Article 8. Law of the Kyrgyz Republic "On External Labor Migration").





Violation by a foreign citizen or stateless person of the rules of entry into the Kyrgyz Republic or the regime of stay (residence) in the Kyrgyz Republic, expressed in violation of the established rules of entry, violation of the rules of registration and overstay of a student visa in cases established by law, entails liability in accordance with the current legislation.



In case of expulsion of a foreign student from the university, from the date of issuance of the order on his expulsion, **this foreign citizen must leave within 10 days:**

For visa required countries - the current study visa is to be canceled and a new transit visa is to be issued;

**In order to ensure law and order and security, prevent possible illegal actions involving foreign citizens and stateless persons, as well as in relation to foreign citizens, it is necessary:**

strictly comply with the legislation of the Kyrgyz Republic in the field of public order, migration and prevent conflict situations;

do not allow yourself to be drawn into illegal acts, incitement of national and religious hatred;

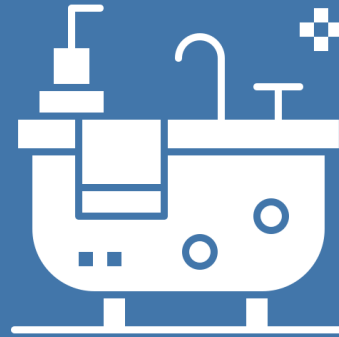


# In places of temporary residence (apartment, dormitory)

and carefully monitor

Observe sanitary

(apartment, dormitory)





**Do not wear white coats, surgical uniforms, caps in public places (buses, squares, streets). Gowns, surgical uniforms, caps should be carefully folded into bags, backpacks.**



**Do not write or distribute provocative, unauthorized information about the local population, about the university on social networks (WhatsApp, Instagram, Twitter, YouTube, etc.).**
