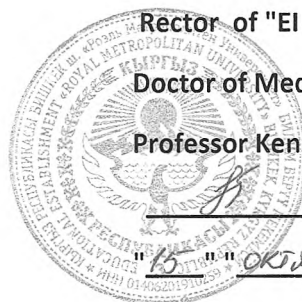
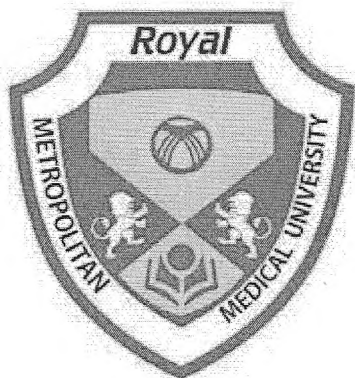

BASIC ETHICAL STANDARDS OF STUDENTS EI RMU

APPEARANCE OF THE STUDENT

Bishkek - 2021

1. RMU students are advised to always look neat, tidy, adhere to a business style of clothing, avoid sports and club (evening) clothing, defiant wardrobe and makeup items. Upon entering the building, men must take off their hats (anything from fur hats to baseball caps). It is considered unethical for a student to wear outer clothing during class.

2. A student of the RMU must comply with the requirements for appearance during his stay at the departments, clinical bases of the University, follow the rules for wearing a medical uniform by students of a medical school.

The medical uniform symbolizes the purity of the doctor's thoughts, strictness in the performance of his professional duties. A neat appearance is always associated with good professional training. Even Hippocrates pointed out that doctors should "keep themselves clean, have good clothes, for all this is usually pleasant for the sick."

**The medical form implies:**

- white dressing gown, impeccably clean, ironed;

In addition to the medical form, the following requirements are imposed on the appearance of students:

- hair should be clean and tied.
- nails are clean, cut short.

You should not use bright, voluminous jewelry and flashy makeup.

The wearing of clothing by students that does not meet the standards of an educational medical institution - tracksuits, shorts, short skirts, slates, as well as other defiant clothing - is not allowed, since it contradicts the norms of medical ethics and is a sign of disrespectful attitude towards teachers and future colleagues.

## **Rules and regulations in personal behavior**

1. Smoking on the territory of the University is strictly prohibited.

2. Distribution and use of toxic and narcotic substances and preparations on the territory of the University is strictly prohibited. The consumption of alcoholic beverages, including beer, as well as being in a state of alcoholic, drug intoxication on the territory of the University is strictly prohibited and entails expulsion.

3. The student must know the name, patronymic and surname of the teacher and treat the lecturer with respect. You should be punctual and show up for class on time. Keep quiet and order during lectures and seminars.

A late student may not be admitted to class. If you are late, you should knock, carefully open the door, say hello, apologize, and ask permission to enter. If permission is received, you need to, without attracting attention, take the nearest free seat in the audience. Actions that in any way interfere with the course of the lesson and interfere with the learning of others: free movement during a couple, conversations, the work of mobile communications, and others. The teacher has the right to remove the student from the class for any violation of discipline. The student is obliged to obey without getting into an argument. After class, you need to politely explain and apologize to the teacher.

4. During training sessions and any official events, the student's mobile phone should be muted. Talking on the phone, using headphones and listening to the player during the educational process is regarded as a gross violation of ethical standards.

5. The University has a strict admission system. Students are required to comply with the access control. In the event that a queue has formed at the entrance doors to the University, students are required to let teachers pass.

6. Students, like all educated people, when meeting, necessarily greet everyone, regardless of the age and status of the person.

7. Students are required to comply with the norms of the culture of speech:

→ address an older or stranger to "you";

→ avoid familiarity when communicating with teachers and staff;

→ avoid slang expressions and parasitic words;

→ do not use obscene words and expressions.

**8.** Students are obliged to take good care of the property of the University: not to break tables, chairs, equipment, to maintain cleanliness and order on the territory of the RMY. It is forbidden to paint on walls, desks and other interior items at the RMY.

**9.** On the territory of the RMY, the use of chewing gum is prohibited during the educational process, as well as during any public events (thematic meetings, conferences, leisure programs, etc.). It is strictly forbidden to stick chewing gum to any interior items on the territory of the RMY.

**10.** Encroachment on someone else's property is unacceptable (even if it is a simple notebook for test papers).

### **Norms and rules in educational activities**

**1.** The student does not cheat and does not use cheat sheets during certification tests, passing the control of knowledge, skills and abilities.

**2.** The student does not seek help from other persons during the certification tests, passing the control of knowledge, skills and abilities that involve the individual performance of work.

**3.** The student does not allow deception of teachers and the administration of the Academy, does not use forged documents.

**4.** The student does not use personal, family or official ties, does not offer bribes to teachers and administration in order to obtain privileges in studies in comparison with other students.

**5.** The student does not violate discipline during the educational process, does not distract other students from the perception of the material.

6. The student refrains from using extraneous and distracting subjects from study (means of communication, entertainment, etc.) in practical classes and lectures, at clinical bases and departments.

RMU student respects the traditions of the University, protects its property, monitors cleanliness and order around him. Outside the walls of the University, a student always remembers that he is a representative of the EI RMY and tries not to lower his dignity and prestige by his unworthy behavior.

### **Conclusion**

1. The technology of implementation of the Ethical Code of Students of EI RMU is the practical embodiment of the ethical values and norms of behavior of this Code.

2. Each student of EI RMU is obliged to know and observe the Code. Not knowing or understanding ethical standards is not an excuse for unethical behavior.

3. For non-observance of the requirements of this Code, students of EI RMU are liable to the Ethics Commission of the Council of Student Self-Government of EI RMU, and in case of a relapse - to the RMU Administration.

4. The following can be used as sanctions for violation of the Code:

- remark, warning;
- a proposal from the administration on disciplinary action (reprimand, etc.) or expulsion from the RMU for reasons that do not contradict the current legislation of the Kyrgyz Republic.
